

NDHU Autonomous Student Committee Benefits and Penalties and Evaluation Method

Approved in the 1st Student Affairs Council meeting in the 1st semester of the 2008-2009 academic year on Oct 22, 2008

Adopted in the 1st Student Affairs Council meeting in the 2nd semester of the 2009-2010 academic year on Mar 29, 2010

Adopted in the 1st Student Affairs Council meeting in the 2nd semester of the 2013-2014 academic year on May 12, 2014

Adopted in the 2nd Student Affairs Council meeting in the 1st semester of the 2016-2017 academic year on Dec 22, 2016

Article 1 Aim

To encourage students to be self-governed members and to reward them for being helpful and serving other students.

Article 2 Target audience

Self-governed members who serve in the dorms of the school.

Article 3 Benefits and Penalties of self-governed members

- I. Guaranteed with beds : Self-governed members are guaranteed with beds during their tenure. If ones has excellent work performance and has average evaluation score over 80, they will be guaranteed with beds for the next academic year. If ones has excellent work performance and has average evaluation score over 90, they will be guaranteed with beds for the following two academic years.
- II. Living fees refund : Those who perform excellent and be helpful in work and has a score more than 70 in evaluation can has housing fees refund. Nevertheless, they are still mandatory to pay the security deposit.
- III. There are excellent dorm representatives being chosen every year and they will be awarded with certificates of merit by dean of student affairs.
- IV. If one self-governed member does not have any bad record after serving for one year, the student living division will reward the self-governed member a certificate of serving.
- V. If ones facing any of the following situations when working as self-governed members, their position will be removed. Moreover, they will lose all welfare and rewards:
 1. Suspend, transfer, or skip school.
 2. Volunteer to leave the dorm.
 3. Violate the rules of the dorm and be expelled (In this case they need to pay the whole housing fees.)
 4. The evaluation score does not reach 60(In this case they need to pay the whole housing fees.)
 5. The self-governed member gets sacked (In this case they need to pay the whole housing fees.)
- VI. Self-governed members shall practice what they preach, if there is verified serious violation of regulations, apart from that their position will be removed, there will be penalty imposed.
- VII. Every time self-governed member is late or absent without notifying for conference or session convened by student affairs or conference, activity, or room rounds, there will be 5 penalty of score of evaluation from the month. If being late for over 10 minutes or absent over three times, their position will be removed and they will be asked to move out their room. Besides, their rights to live in dorm next year will be canceled.
- VIII. To encourage self-governed members to take up tasks, every time they find a violation of dorm

rules, they can get 0.5 bonus of the evaluation for the month after the violation being verified. The maximum of bonus for a month is 5.

- IX. If ones' average evaluation score during their tenure does not reach 60, their rights to attend the election of self-governed members will be canceled.

Article 4 Method of evaluation

As self-governed members, they need to accept the evaluation from dean of student affairs, supervisor of service management, administration center of NDHU Autonomous Student Committee, dorm manager, and the other self-governed members from the dorm.

Article 5 The Regulations shall come into force after being adopted by the plenary meeting of Student Affairs and submitted to the president for approval. The same applies to the amendment of the amendment of the Regulations.
